- Music - Your single selected cut on an otherwise clean CD
- Valid NPC Membership Card or cash to purchase membership. (approximately \$100.00)
- Posing trunks/suit

## Show Schedule

**MANDATORY COMPETITORS MEETING AT 8:30 AM ON SATURDAY NOVEMBER 5, 2011**

Pre-judging 10 AM

Evening show at 6 PM

## Eligibility

1. Each competitor must be registered with the NPC and must present a current NPC membership card, current NPC membership payment receipt or purchase an NPC card at this competition.
2. Each competitor: A) Must have reached their 35<sup>th</sup>/40<sup>th</sup>/50<sup>th</sup>/60<sup>th</sup> or 70<sup>th</sup> birthday by date of show. B) Must provide proof of age with a birth certificate, driver's license or state ID.

## Divisions

**Teen Men:** Must have reached his 13<sup>th</sup> birthday, but not his 20<sup>th</sup> birthday by date of show. **Novice Men:** Cannot have won their class at a NPC contest; **Masters Women:** 1 Class; **Novice Women:** 2 Classes; **Novice Men:** Lightweight, Middleweight, Light Heavy, Heavyweight Bantam Weight = 143 ¼ and under, Lightweight = over 143 ¼ and up to and including 154 ¼, Middleweight = over 154 ¼ and up to and including 176 ¼, Light Heavy = over 176 ¼ and up to and including 198 ¼, Heavyweight = over 198 ¼ and up to and including 225 ¼, Super Heavyweight = 225 ¼ and over. **Women:** Lightweight = 118 ½ and under, Middleweight = over 118 ½ and up to and including 132, Heavyweight = over 132, **Masters Men:** 5 classes, 35-39, 40-49, 50-59, 60-69, 70 and over. **Teen Men:** 2 classes to be determined at the show. **Women's Figure:** 3 classes, A, B, C **Women's Masters/Figure:** 1 class 35 and over. **Men's Physique,** 2 classes – short - up to and including 5'8" – tall - over 5'8".

## Show

**Prejudging:** No free posing in the morning.

**Posing/Music:** Evening show: 60 seconds posing with music. At check-in, each competitor must provide 1 CD with your selected music cut on an otherwise clean CD. All competitors will be presented at the evening show. In case of failed CD, house music will be provided for your routine. Music must not contain any profanity.

**Awards:** Trophies awarded to the top 5 places in each weight or age class and to the overall winners of the Men's and Women's divisions. First and second place winners in the Men's and Women's divisions qualify for national-level competitions.

**Rules and Entry Fees:** Light oil allowed. Athletes who compete in pre-judging must participate in evening show. Solid color posing suits only. No T-back suits permitted. No jewelry is permitted (except wedding rings). Athletes must exhibit good sportsmanship at all times. Only competitors and officials are allowed backstage or in the pump-up room. Current NPC rules apply. No Hot Stuff or Analgesic sprays are allowed (no exceptions). No bottled tanning lotion allowed in building. Please have your tanning preparation done before you arrive. You will be disqualified for putting tanning oil on in the building.

**Entry Fees: A \$75.00 check or money order is required for each division entered and must be accompanied by a completed entry form. Entry fees are non-refundable.** All entries submitted by mail must be postmarked by Saturday October 22<sup>nd</sup> or a late fee of \$50.00 will be charged. **NO ENTRIES ALLOWED OR ACCEPTED THE DAY OF THE SHOW. LAST CHANCE TO ENTER IS THE DAY BEFORE THE SHOW AND IN PERSON AT USA GYM, 7621 W. 100<sup>th</sup> PLACE, BRIDGEVIEW, IL 60455.**
